## Old Business

Joey: Budget timeline is unfrozen. Yay! That's all good for all of you guys! Also, for community service, I sent an email out to every Club in regards to community service under the 24-hour requirement. If you have any questions about that, please feel free to email Autumn. sent that over to a unit that will be able to distribute the supplies; and that was used by the Beaver Community Endowment.

## New Business

Joey: Suggested budget allocation. Ryan, will be coming up to talk about it.
Ryan (Financial Manager): First off, thank you to all the clubs. 31 clubs submitted the budget and 30 got some funds. The only exception is outdoors club, but I didn't hear anything from them. This week is the appeals week, which are due 5pm tonight in the Campus Life office. I already had two appeals and had reached out to both clubs, to meet and discuss about their concerns. I will explain some of the cuts that we had to make. A lot of it had to do with club spending. I went to Campus life to get the report and saw that some clubs weren't really spending the money. With that said, I decided to do a $25 \%$ decrease, after I threw the book at you, if you didn't spend the allocated money. Then I did a $10 \%$ increase if you did spend it. If you have any questions, I'll be more than happy to elaborate. Stand for State, Nicolette, we talked about that; so I added it on here instead of tabling. All the club budget is on this sheet and we're ready to vote on February $1^{\text {st }}$.

Joey: The $\$ 110,000$ is how much all clubs requested, which is a sign that you guys want to do a lot. However, SGA can't allocate that much due to SAF. To keep a small window for new clubs to come in, this is the number we'd show.

Ryan: That is also why I implemented the $25 \%$ decrease and $10 \%$ increase because even with the books, you guys were still over the amount.

Troy (Chamber Choir): Is Chamber Choir up there?
Joey: Yep, it's up there.
Ryan (Financial Manager): Like I said, if you have any questions, don't hesitate to come up to me.

Kyle (Honors): motion to second the Budget Request until February $1^{\text {st }}$
